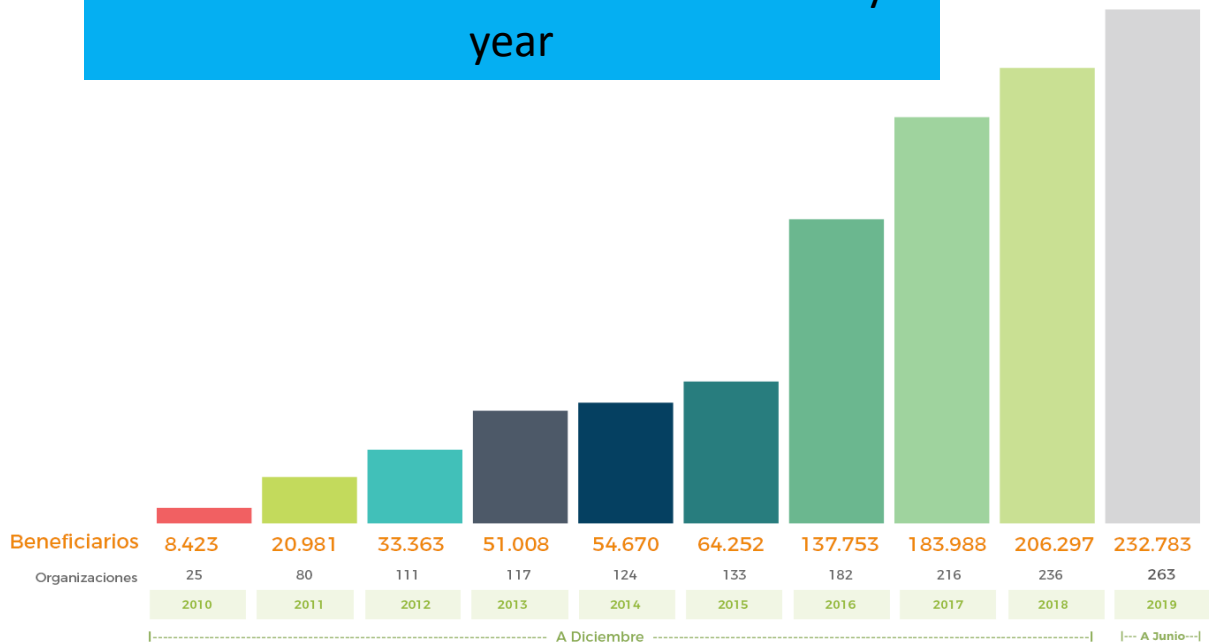

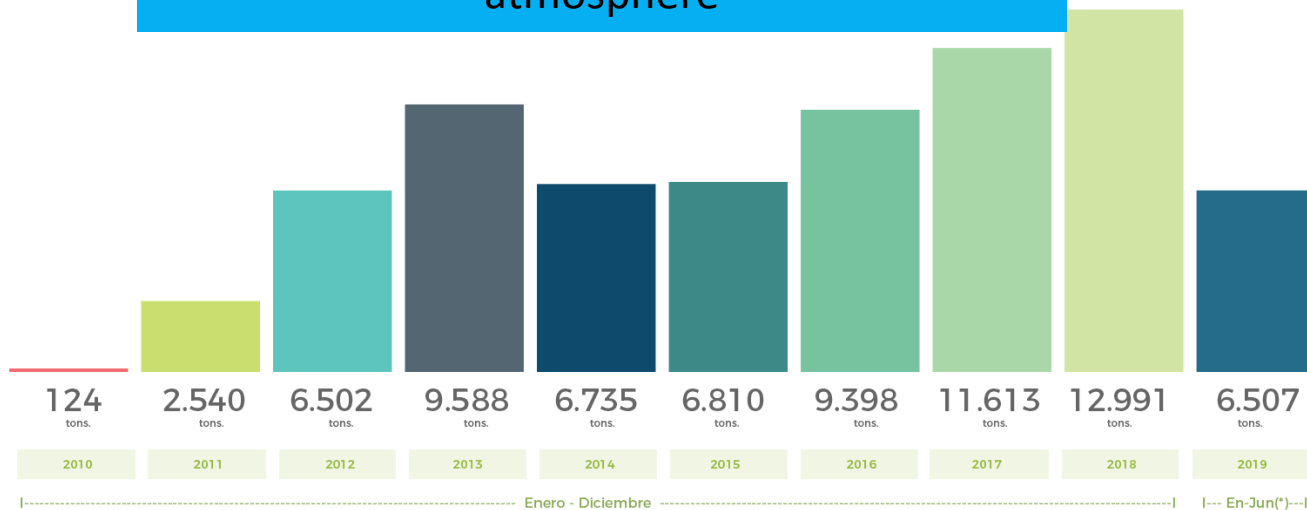

National Plan of Action on Sustainable Consumption and Production

- Present activities committed through the roadmaps of each line of action and monitor PNCPS.
- Have an instrument that allows to demonstrate the scope of the objectives of each line of action and the initiatives reported by every stakeholder.
- Facilitate the analysis of the link between initiatives reported and SDGs at a global level.



1st Latin American economy to hold a Climate Change Adaptation Plan on Fisheries and Aquaculture

29 Adaptation measures or actions on five areas:

- Promote implementation of precautionary and ecosystem approaches on fisheries and aquaculture
- Improve knowledge about the impact and different scenarios of climate change
- Disseminate and inform about the impacts of climate change
- Improve legal, political and administrative framework
- Develop direct management measures to reduce vulnerability and impact of climate change





c) Support needed to enhance institutional, financial, and technical capacities to address FLW in ways that can accelerate climate actions or enhance climate resilience in your economy

Measurement and management of fruits and vegetables loss at production level in Chile

Objectives

- Collect information regarding FL in domestic chains of fruits and vegetables.
- Adapt and validate an international methodology of quantification of fruits and vegetables loss.
- Identify the main causes of losses and best practices to prevent and reduce them in Chile.
- Strengthen capacities and promote experience sharing of producers and stakeholders on the prevention and reduction of fruits and vegetable losses.





Currently, the Undersecretariat for Fisheries and Aquaculture has applied for domestic funds to develop a project to collect indicators and establish a baseline for fisheries and aquaculture waste. The results will be available in 2022.
